DOGS IN CARS ON HOT DAYS

Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog

If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.

The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any field trial licensed by the Kennel Club. This shall apply at the venue or within the precincts of the trial.

Dogs entered must be registered at the Kennel Club in accordance with Kennel Club Regulations for Classification and Registration B.

All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the event can be made. All overseas entries without an Authority to Compete number will be returned to the competitor.

Judges at a trial are prohibited from entering a dog which is recorded in their ownership or part ownership.

If entries exceed the number of permitted runners, the right to compete in a trial shall be decided by ballot.

The Society reserves the right to refuse entries. Substitutions will be allowed with suitably qualified dogs where appropriate so long as the secretary has been advised of such substitution.

Should circumstances dictate the Society, in consultation with the judges, may alter arrangements as necessary. Such changes and the circumstances surrounding them must be reported to the Kennel Club Ltd at the earliest opportunity.

No modification will be made to the schedule except by permission of the Kennel Club Ltd, followed by advertisement in appropriate journals if time permits before the closing of entries.

Videography and photography will only be permitted with the express permission of Chief Steward and the host.

A competitor whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not knowingly put their dog's health and welfare at risk by any action, default, omission or otherwise. A breach of this Regulation may be referred to the General Committee for disciplinary action under Kennel Club Rules and Regulations.

Entries must be in the hands of the secretary by the date shown on the schedule. Anyone unable to run must notify the secretary by telephone (landline please), 01206 251426.

The running order of the stake will be in the order of the draw.

Withdrawals will be dealt with in accordance with Reg.J7.

If you are on the reserve list and do not intend to take a run, if offered, please let the secretary know, even if you are well down on the list.

All mobile phones must be turned off when called into line.

All trophies to be returned 1 month prior to date of trial. Failure to do so will mean a fine of £25.00

Please only use the entry form for one trial, ensure all details are filled in correctly, legibly and that it is signed or I will have to return it which could mean missing the closing date.
